- 5. You put in what you get out!

Terms and Conditions

- 1. Currently only offering to Pucci clients with possible consideration from referrals.
- 2. There will be a limit of 6 dogs per walk.
- 3. Location to be decided on prior to the walk.
- 4. Please respect all other dogs and handlers on the walk.
- 5. If your dog needs to wear a muzzle, please let us know prior to the session and ensure you bring a well fitted, proper muzzle that they can pant and drink freely in.
- 6. Please ensure that your dog's hardware is on properly Collars on securely enough that they do not pop off over their head.
- 7. All dogs should be wearing a well fitted collar and come along with a good sturdy lead. No flexis or harnesses.
- 8. Please ensure you turn up at least 10 minutes prior to the walk commencing to ensure you're ready to roll.
- 9. Please bring poo bags and use them.
- 10. Please kindly ensure payment is made prior to the walk.
- 11. Most importantly, let's have fun.

Liability

If your pooch causes property damage, or bites or injures any dog, animal or person (including but not limited to Trainer and Trainer's agents), during or after the term of this Agreement, then Client agrees to pay all resulting losses and damages suffered or incurred, and to defend and indemnify Trainer and Trainer's agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees. If Dog is injured in a fight or in any other manner during or after the term of the Agreement, Client assumes the risk and agrees that Trainer should not be held responsible for any resulting injuries, losses, damages, costs or expenses.

At Trainer's sole election, Trainer's duties hereunder shall terminate if (a) in Trainer's sole judgment Dog is dangerous or vicious to Trainer or any other person or animal, (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Trainer's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect.

This Agreement is binding upon Client, spouse of Client, and children of Client. This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between Client and Trainer regarding the matters described above.

The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or oral understandings have been made with regard to Dog or anything else. Without limiting the generality of the foregoing, Client acknowledges that Trainer has not represented, promised, guaranteed or warranted that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioural problems, or that the results of the training will last for any particular amount of time. This Agreement may be amended only by a written instrument signed by both Client and Trainer.

For good and valuable consideration, the parties agree as follows:

Training Fees:

1. Client agrees to pay Trainer a non-refundable fee to the agreed price of session.

All sessions must be completed within 180 days from the date of commencement of contract or they will be forfeited.

Services: Trainer agrees to provide private lessons for Client and Dog on a lesson-by-lesson basis, the goal being to teach Client how to train and work with Dog. These lessons will take place at Client's home or other agreed venue. Trainer will make every reasonable effort to help Client achieve training and behaviour modification goals but makes no guarantee of Dog's performance or behaviour as a result of providing professional animal behaviour consultation. Client understands that he/she and members of the household must follow Trainer's instructions without modification, work with dog daily as recommended, and constantly reinforce training being given to Dog. Cancellation Policy: If Client fails to give at least 24 hours cancellation notice, or is not present at time of scheduled appointment, session fees are still due.
